I am directed to refer to your application for grant of Continuation of Recognition of MBBS degree (250 seats) awarded by Gujarat University, Ahmedabad, Gujarat in respect of the students being trained at B.J. Medical College, Ahmedabad and to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment during the final MBBS practical Examination on 1st and 2nd August, 2022 and physical verification of the facilities on 2nd February, 2023.

2. The above assessment reports alongwith the data available on AEBAS and HMIS including CCTV footage was considered in Under Graduate Medical Education Board (UGMEB) and certain deficiencies were noted. The same were communicated to the college authorities vide UGMEB's letter dated 24.05.2023 for compliance.

3. In response to the above, the B.J. Medical College, Ahmedabad has submitted their reply vide letter dated 02.06.2023 with regard to the deficiencies pointed out by UGMEB in its letter dated 24.06.2023. Subsequently, an opportunity of the personal hearing was also given to the college authorities on 13.06.2023.

4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by the UGMEB that B.J. Medical College, Ahmedabad, Gujarat is granted **one year** Continuation of Recognition of MBBS qualification. However, they shall apply afresh for Continuation of Recognition in 2024.


5. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **CONTINUATION OF RECOGNITION FOR ONE YEAR** for MBBS degree for 250 students, awarded by Gujarat University in respect of the students being trained at B.J. Medical College, Ahmedabad.
