Preamble:-

Presently, the State Government charges very nominal tuition fees as shown below in the Table- A from the students who are admitted to Professional Medical Educational courses in Medical, Dental and Physiotherapy Colleges being run and managed by the state Government, vide resolution of even number of this Department, dated 28/05/2003 as read at serial no:-1. These rates of fees are very low in Government colleges compared to rates of fees prevailing in the Self-Financed Colleges of the state and Government Medical Collages of other states.

The Government of Gujarat incurs huge expenditure for imparting education to students in Government Medical, Dental, and Physiotherapy Colleges. Therefore, the Commissionarate of Health, Medical services and Medical Education, recommended to the Government to revise fee structure for students for admission to Undergraduate Medical, Dental, Physiotherapy, Occupational therapy and Prosthetics and Orthotics courses in the Government Colleges, vide its SFS note, dated:07/06/2018 as read at Serial no:-2.

Accordingly, the issue of fixation of revised annual tuition fees to be charged from the students for admission to Undergraduate medical courses in the Government Colleges was under active consideration of the state Government.


