**BOND FOR CANDIDATES PROVISIONALLY ADMITTED TO D.M./M.Ch. COURSES
AT GOVERNMENT MEDICAL COLLEGES, GUJARAT.**

This indenture bond made at..... on the.....day of two thousand.....between the Government of Gujarat (hereinafter referred as the Government) which expression shall unless the context otherwise admits / includes his successor in office and assigns of one part and Shri/ Smt./Ms.....residence of (permanent address).....in the Taluka of.....district,.....State (hereinafter referred as the candidate) of which expression shall unless the context otherwise admits / includes his/her heirs, administrators, executors and assigns of the other part.

WHEREAS the Government has decided to prescribe a condition for admission to Government Medical Colleges/ U.N.Mehta Institute of Cardiology And Research Centre/ Institute of Kidney Diseases And Research Centre/ Gujarat Cancer And Research Institute for the D.M./M.Ch. courses (hereinafter referred as "the said course") that every Candidate so admitted shall complete the said course from that college and on such completion he/she shall serve the Government for a minimum period of 1 year in any of the Government Hospitals/GMERS Hospitals of the Gujarat state on such remuneration as may be prescribed thereof and shall furnish a suitable bond for the due performance of the said conditions.

AND WHEREAS the Candidate who had applied for admission for the said course in..... Medical College(hereinafter. referred to us "the said college") has been admitted for the said course.

NOW the condition of the above written obligation is that if the Candidate shall:

(1) Fail to complete the D.M./M.Ch. course as hereinaabove provided that candidate shall pay to the Government on demand, the amount of penalty of Bond, as prescribed hereunder.

(2) Diligently prosecute and complete the said course at the said college or any other Medical College or Institute in the state and pass the prescribed university examination for the said course and within a period of 30 days from the date of his/her result declared by University/completing the period of Super Specialty course give by a REGISTERED POST NOTICE and/or electronically through E-mail address as intimated from time to time in writing intimating the completion of his/her period of Super Specialty studies to the Government and,

(3) When called upon by the Government at any time within a period of TWO MONTHS from the receipt of the notice from the Candidate as aforesaid join the state services and serve in any of Government Hospitals/GMERS Hospitals of the state for a minimum period of one year at such remuneration as may be prescribed thereof. And in the event of the Candidate not being called upon by the Government to join the state services and serve them for the aggregate period of one year in any of Government Hospitals/GMERS Hospitals of the state during the period which the Candidate is required to serve under provisions of this bond faithfully discharge the duties assigned to him/her by the Government or his/her other superiors with utmost diligence and efficiency and shall observe the rules for time being in force regulating the conduct of persons so serving.

Then the above written bond shall become void otherwise the said shall remain in full force and virtue.

And in the event of Candidate committing a breach of any of the above terms and condition, the whole amount of Rs.50,00,000/- (Rs. Fifty Lakhs only)(i.e. Solvency Certificate or Bank Guarantee of Rs. 15.00 Lakhs and Undertaking of Rs. 35.00 Lakhs) as per Government of Gujarat, Health and Family Welfare Department, Resolution NO. MCG/ 1022/SFS-26 /J, dated-02/04/2022 or such lesser sum as the Government may decide as it's absolute discretion shall become payable jointly or severally by the Candidate or the Surety of the Candidate.....(Full name of the surety).....

.....(Address) forthwith the Government may without prejudice to any other rights and remedies of the Government, to recover the same from the Candidate or above surety.

And upon making of such payment the above written obligation shall be void and of no effect. otherwise it shall be and remain in full force and virtue;

Provided always and it is hereby agreed and declared that the decision of the Government as or whether the said Candidate has or has not performed and observed any of the obligations and conditions herein before recited and shall be final and binding on the parties hereof. Government may at its discretion may decide and inform the candidate to perform such duties as it made deemed fit for the fulfillment of above mention Bond.

Provided further that the liability of the surety hereunder shall not be impaired or discharged by reasons of time being granted or any forbearance, act of commission of the Government (With or without knowledge or consent of surety) in respect of or in relation to the several obligations and conditions to be performed or discharged by Candidate provided that the government may without prejudice to any other rights or remedies of the Government to recover such amount due hereunder from the Candidate or from the surety as an arrears of LAND REVENUE and provided further that this bond shall in all respect governed by the laws of India. The expenses on the stamp duty on the bond if any, shall be borne by the Candidate.

I DO HEREBY JOINTLY and each of us severally firmly bind ourselves, our sureties, our respective heirs, executors, administrators and legal representative by these presents. Signed this ____ day of _____ whereas the **Government Medical College/U.N.Mehta Institute of Cardiology And Research Centre/ Institute of Kidney Diseases And Research Centre/ Gujarat Cancer And Research Institute** in the state for the Super Specialty course. (i) Every Candidate should admitted shall complete the Super Specialty Course from the college to which he/she is admitted or from any other Government Medical College (ii) he/she shall if required by the government serve the **Government of Gujarat for a minimum period of one year** on such remuneration as may be prescribed thereof (iii) he/she shall furnish the

government a personal security Bond in the described form in the sum of Rs. 35,00,000/- (Rupees Thirty Five Lakhs only) executed by the Candidate.

NOW THE CONDITIONS OF THE ABOVE WRITTEN BOND ARE THAT:

- (i) The Candidate shall diligently pursue and complete the Super Specialty course at the said college in the state of Gujarat and strictly comply with the rules of the said college. The Candidate shall have to attend the college regularly and shall complete the course passing the prescribed university examination.
- (ii) After passing the said examination and at such institute, the Candidate shall **within a period of 30 days**, inform to the Commissioner of Health, Medical Services, Medical Education and Research(hereinafter referred to as CoH) to offer himself for the Government Services and if the Candidate is called upon by the Government or CoH, the Candidate shall serve the Government for one year in such grade and remuneration as may be prescribed by the Government.
- (iii) During the period of Bond services, the Candidate shall be required to serve under the provisions of the bond and faithfully do the duties assigned to him/her and observe the rules for the time being in force regulating the conduct. The Candidate cannot remain absent without prior permission of competent authority.

IT IS HEREBY AGREED AS FOLLOWS :-

(a) In the event of the Candidate committing a breach of any of the above terms and conditions, the total sum of Rs. 35,00,000/- (Rupees Thirty Five Lakhs only) shall become payable forthwith by the Candidate himself/parents/guardian and either of the sureties jointly and severally and the Government may, without prejudice to any other rights and remedies of the Government recover the same from the Candidate and / or either of the sureties jointly and severally at the discretion of the Government as arrears of Land Revenue and can attach the land or property of the above.

(b) If the Candidate before or after entering Government service, becomes ineligible for appointment or continuation in Government service by his own misbehavior, indiscipline or irregularity, he / she shall render himself/herself liable to pay to Government in addition to the said bond amount penalty for breach of agreement as may be decided by the concerned Government officer and such amount will be recovered from the Candidate /parents/ Guardian /either of sureties as the absolute discretion of the Government.

(c) It shall not be necessary for the Government to inform any of the Candidates before suing either of the sureties for recovering the amount due hereunder.

(d) The liability of the sureties hereunder or either of them shall not be discharged by any reason.
